By granting permission you also:

- 1. Release the school district from any liablity that mighnt be incurred as a result of granting this permission, as well as waive and give up any and all claims related to the foregoing.
- 2. Understand the district is not responsible or liable for another person's posting or online sharing of your childs likenes or personally identifiable information
- 3. Understand the no home adress, email address, or telephone number will appear with your childs picture or work on any district communication platorms. Persuant to law, we will not release any personally identifiable information without prior written consent from you as parent or guardian, unless as part of an athletic and/or academic team, performing art group and/or other public performance bsed activity or as part of a large group photograph submitted without names. As you are aware there are potential dangers associated with the posting of personally identifiable information on a website since global access to the internet does not allow us to control who may access such information. These dangers have always existed, however we as a school do want to celebrate your child and his/her work.

The law requries that we both ask for your permission to use information about your child. This media consent form is to both inform and to give you the option to "opt out" of giving media consent pemission.
