Superintendent report-Written Report Given-Coal Board meeting for the Big Horn county. I got up in front and we were granted \$83,700 for the roof. The report was estimated at \$107,000. We went with the most expensive firm. Tsukat agreed to do the roof for \$80,000. In January the money will be given through acceptance letters. There are no matches needed. We present a report after the money is spent in a year, which was agreed. Bed Bug issue, we found bed bugs on students, not directly in the classroom. (Custodian-change up their routes/responsibilities, clean building, ground around the school are the maintenance.)

Sampson joined the meeting at 6:29 p.m.

(Kitchen, Maintenance)-the truck is in the shop, a valve needs fixing. Boiler #1 out of 4 is blowing out cheap parts. Service 4 states with two guys. We are going to try "Allied Mechanical". The seats were replaced in the gym. Replacement for all seats \$5,500 total. MDU is going to be here today or tomorrow to install the gas meters. Cleaners can come and clean it all out. Re-evaluate the housing units for fixture, one house requires re-piping-we do not have this in the budget, we may look at removal. Sampson-this was the only other unit? Eric-yes, mirrors, gym seats, buses & bus barns. What do we do with all of the possessions at this point? We have offered her to come get it, we could offer anything decent to the community. Plan is 2 weeks for her to get it out.) Covid policy no longer exists due to more knowledge and following the other schools & guidelines. Big Sky is offering our kids to go skiing for our students. Loren Rausch has taken on the responsibility to make this happen. Late January, early February. Community outreach-we will continue to go out and reach out with the community. Half our time has been spent on basketball issues. It's a community issue, more discrepancies.

Principal-I have been very busy, teacher observations, 6 currently needing to finish. Basketball concerns, instructional coach, reading specialist, we are working on moving money where it is needed, Step grant, gear up grant. Constructing collaborative teams, JOM committee, OPI, 7 teachers will be working on a teaching tool, time &

students. They will not be happy, learning tools to help them be the best that they can be.

Business manager-Standard Payroll, final term of ESSER budget, we invite the board to join us. Most of the money is tied up in construction. Candis-we may have to lay-off 2 para's. We may have it covered. Final audit results back from last year's audit. We have responded, the state agreed with the plan.

Letter from family of a student

Eric-AD was being spoken to by parents, moved from varsity & JV. When he was confronted, refused to write a formal complaint. Formal complaint is in front of you.

Cynthia-student has been here, Summer she wanted to be here, time & effort. Why are you not on varsity? Robyn-nothing in writing to show us, where is his back up? Cynthia-have you talked to the assistant coach Angel? Robyn-she said she doesn't agree with him. Kenny-she

was able to make a team elsewhere, we attended the metra tourney, the team had 8 players. The only one who didn't have 12 players, she is a senior and she wasn't playing. We got his cell phone number from the Ad director, and we requested a refund. The front office at the metra said the AD has to approve the refund. He did not respond to my text or phone call. We had to take leave. Upsetting, why isn't she playing when she dedicated herself during the off-season? We are here to advocate for you. Candis-can you explain to me why? Student 1-day before, he had a freshman from JV play for varsity. When he was talking, who was eligible, had us raise our hands. Me, my sister, 2 other students, I don't know if you can play or not, I have the rules. When it came the day of, he allowed other players to play. How many other girls played? Student 1-3 other players Sampson-he didn't say anything? Robyn-he has 14 players that he can play. Candis-did we have a conversation about 1 of the players that put soap in your drink? You are low key bullied. Based on history, their coach, as a principal that does not have it, is not acceptable. Carol-he was always texting me back and I have it. I would see him, he stopped, when I saw him, he said do you have a text? The office here at the metra, family needs to be reimbursed. I did not get reimbursed. He wouldn't respond, so I dropped off my granddaughters. Student 1 & Student 2 wanted to be a part of the team. If you go and tell the metra, my daughter's tickets will be reimbursed. I talked with Ad's mom as I work on a board. She said it's not my business. I told him, I couldn't get the tickets reimbursed. I gave the kids the tickets for reimbursement of the tickets, and he told Student 1 that they could not get reimbursed. He answered another grandparents' calls, he's related to a player on the team. A mom and grandparent are related. Robyn-it feels that there is something against us. Candis-do you have the tickets? Robyn-yes Candis-bring them today.

Student 1 has played basketball her whole life, she is a senior, negatively impacted her ability to play emotional distress, accountability of being a coach, promoted to varsity. I want to know what kind of chart to determine her not being considered. Why are there 14 spots? The team should have a full squad. Proper background check of previous schools. Possibly his removal, regarding separation findings. Candis-I have had rumors of other schools, has he had any negative gestures towards you? Does he allow other players to do so? Student 1-No Vance-father, I held back to fight him, focus on your studies. In crow, we speak Crow, we love our daughters, we take care of them, we don't walk around without shirts in front of our daughters. We don't do that in front of girls. FERPA laws- he brought names from other schools, from Rocky Boy. As an educator, we don't talk about other students. If he's a teacher, we don't talk about another student. He said the girls' parents were drug addicts, and talked about how he had to pick up the girls for practice. This was at a potluck we had, he talked about it. Disclosed former players. Eric-concern and talking about other students and schools. Cindy-what's the purpose of it? Robyn-I didn't think that was right. Sampson-request executive. Carol-I'm going to speak in Crow and I'll translate it into English the best way I can. In our culture we are caring, when you go and talk to someone if this was years ago, compassion, pity, we have a lot of that being Crow. I don't see this in him. He is not willing to do that. In the Crow way, when you plead with somebody, you work with them, that's what I said in the Crow language. You as administrators & the board will do something to help her. Jason-emotional distress has caused trauma. She is lucky to have a 2 parent home. If it was any other child, you would see problems with substance abuse. Give her the benefit of the doubt.

Eric-the next agenda item is about the attendance, 10 day policy. This does not matter due to 23 absences. The student has had continuous absences. Absences from 2nd period. He shows up more for the other classes. He currently has 0 credit. Reverse & give credit. Eligible

to get credit. Same thing he would need to get eligible. Right now according to policy he has 0's. Candis-Math & English? Jason-1st period class is shop. Eric-The student has an LBHC course, Dale would have told him, do this and you will have a passing grade. Policy, you can rescind that, board decision. Jason-I think it's important, the habit, internally, I'm not saying he is in the right. What class is he intentionally missing? Eric-The student hasn't come to school, sleeping in class, if those things are not working, I talked to him about not liking his teacher, you still have to do the work. Issues with the teacher, he hasn't been coming, he needs to show up and do the work. I talked with his grandmother and said that he needs to do the work. Candis-the pain that I could see with this student, I do not feel whether or not he sees credit. Next semester, he can be moved to credit recovery. Eric-the student wants to play basketball, needs to pass the class. I have offered, the student can come to my office at lunch, I can tutor him, Rausch, Dr Day has offered. Sampson-an agreement between the board and the student, to go with the policy, Christmas break he could catch up. Is there any other place where he could do the work? Candis-Yes Eric-not going to class, would be helpful, I was thinking, put a laptop with a video to watch her period, help out during that period. However we work this out, options for help. The student doesn't show up. Jason-the folder that the student completes, he brings back, I helped him with one packet, he did the other on his own. Eric-2 grades, C, 100 & a 0. Jason-we were under the impression that he cannot make it up. The work that he turned in. Jolene (grandmother)-even if he turns it in, 50% of his grade. Eric-I wouldn't say that about him. Jolene-to me maybe he has issues, counselor, we recommended that to him. Dr's note. Why is it that he didn't reach out to him? I've talked to others regarding students, it's to a point where there is a failing grade, not able to participate in basketball. This student feels bad and not encouraging, is there concrete evidence that this student is being reached out to? Eric-emails, the student is showing up at school & doing his work. He can do it, I know he can do it, he's smart and he can do it. Jolene-he had a NASA teacher here, he is impressive. For whatever reason he doesn't want to attend his class. Jolene-accepted the Ad's about the qualifications of the rules. Eric-No F or 2.0, can that be changed? Eric-the board can make changes. Jolene-I know now it can't be changed, unless the board makes that change. Eric-different situation with another student. This is not a teacher issue, the student is not showing up and not doing his work. He needs to pass the work. Jolene-he is a student, and he needs to be helped. Eric-If he chooses not to do the work. Jason-It's the same thing, sleeping in class, assignment. Eric-It's not what the teacher said. Candis-There's 12 packets, the ones from the first quarter. Eric-if a child sleeps in class, you can't count a child, they are tardy. Jolene-same thing? Cynthia-as a board, Eric-I will recommend for the board to pass his class and do the work, state law. Sampson-the work if he gets 100% of late work, not graded to 100%? Candis-vote regardless of the absences, are you going to do this for the 36 students? Eric-All other students, the same for all and it does open up the doors. Sampson-I agree with it, It would encourage the students. Cynthia-I would like to see a contract with another student. Mental health is a big thing. Eric-I want him to have the chance, we can't give the stuedent a free grade, it's state law. Cynthia-If we can see those contracts, write and hold the contracts. Once basketball season is over, are all these students going to be absent? Sampson-we're not at the point. Eric-begin a Crow league for the students, it may take extra. Jason-last 2 emails. the reason not lectured, work was considered to be napping, reason for not being graded. Response-brand new policy as of last Monday, any assignment, full credit, does it have to go through the board? Eric-teaching matter, board and superintendent cannot, it's policy. Jason-Has it been notified to the public, my communication has been held up with the counselor. I have all the communication through email, ones more active, why shut him out? She (teacher) could speak on her own behalf. Eric-she cannot due to verbal abuse. Jolene-my granddaughter was transferred from Hardin to Bozeman, she went through a personal matter. Eric-parents have access to infinite campus, progress reports, constant contact. Jolene-what about their homework? I'm not looking for an excuse. Candis-do we

send an alert when an assignment is missing? Jolene-my concern is how he was addressed. The student in the classroom, he's trying, gave his homework, Ms. Day, it seems she turned around. I'm not grading you. Needs to be treated on an equal basis. Personality clash, it comes to this. Candis-conflict of interest, decision to pull the student from the class for credit recovery. Tutoring with Mr. Terrill, pulling from the class to sit in my office, I can help with the student's class, the student can continue to try to do his math. Best I can do, moving forward, if this is what the board decides, is to write the contract for the Superintendent, the board is satisfied, and request every missing packet the student has. Help the student get this done, help the student in his moment of need, I am going to do everything I can do to help the student according to board policy.
