3) PUBLIC COMMENT

The Board recognizes the value of public comment on educational issues and the importance of involving members of the public in its meetings. Individuals wishing to be heard by the chair shall be first recognized by the chair and after identifying themselves will proceed to make comments as briefly as the subject permits. The chair may interrupt or terminate an individual's statement when statements are out of order, too lengthy, personally directed, abusive, obscene, or irrelevant. The entire board shall have the final decision in determining the appropriateness of all such rulings. Members of the public shall be recognized and allowed input during the meeting, at the discretion of the chair. It is important for all participants to remember that board meetings are held in public but are not public meetings. If the Board understands the language of a public comment, translation is not automatic, and the Board will proceed forward with meeting business. Upon request, the Board will provide translation of public comment or business discussion conducted by the Board. Social conversation not in relation to decision-making at meetings will not be translated.

Superintendent report-Attendance has seemed to drop a little bit. Maker Space room; 3d printers, doodle pens, circuit board, drones. A professor from U of M will be helping coordinate that. Basketball court foundations are both being poured and in place. Testing will begin tomorrow. We are ahead of schedule. (Kitchen, Maintenance: adhering to teacher requests. Maresco engineer walk-through regarding our major issues & needs. We did not receive the grant for the roof. We have located a major leak in our roof. We need to pull an air handler out which in the past was a \$30,000 quote. Bus Transportation: We are missing stops due to the application. He is working on the greenhouse, maker space, housing etc.

Principal (Gear-Up,Custodian)- I have seen some fantastic teaching, the students enjoy being at school. We will be providing CPR/1st Aid training for students and the kitchen staff. The orders will be in. The students will be enjoying the meals. The elementary curriculum is being built; consistency, begin with everyone being on the same page. State standards for grading. Allow them to move on to the next grade level. Classroom to classroom to identify strengths. PIR days will take place in October. Approve attendance by offering incentives. End of the week Friday. Grading needs to end by the end of the day on Tuesday. Provide a consistent system for grades to know who is eligible from week to week. Hold the students accountable for their grades. Dual enrollment began with Little Big Horn College. The teachers are willing to be flexible with schedules.

8) PERSONNEL ITEMS

a. Union Grievance

Carlson-Before I turn the floor to you, I would like to say a few things. I was previously a board member here. The union has a lot of leverage. We are elected, and the union is not. When they come before the board, they come to the school. We have won our past cases. Trustee: natural or legal person who is a benefit to the students number 1. We come in for the hiring of the faculty, staff, bus drivers, for the benefit of the students and safety well-being. We were elected by the community members, is how we get elected. We make decisions that are unpopular. My point is the decision we make, regarding the discipline of employees. The union has been given the leverage. The others were the ones interviewed. Paid dues to watch their backs. You do not invest in our community. Job opening here. The previous board has made poor decisions. I was a negotiator to the past. Some of the coaches we hired were capped. Increases include the union, it gets capped. \$25.00 was requested. If a raise is given to one group, it's given to all. The money comes to the school and to the board of trustees. Bus driver and AD. Other schools are not like that. White man AD, Indian. Rubber stamp. Arbitration to sue. Union CBA agreement. Arbitration decision is final.

Channis-for me, I wasn't chosen. It seems that we don't have power. Difficulty: A coach had a right to sue but didn't do so. We thought it over and we changed it. My son wanted to apply. My own thinking. Why are we elected if we don't have any voice? Carlson-I will face the community.

Rachel Schrileff MFPE statewide union. Billings education association present. I worked within this community for the local area for four years. It's easy to be angry with

me. I represent the community members. I do not bring forward. I advise them on laws. your local employees are the ones who bring it to me. Contractual language wasn't changed while I was here and in the past. Individual issues regarding pay. The classified employees did not open it. What's best for your budget? I serve 22 different locals in 16 different cities between Roundup, Bridger, Wyola, Broadus etc. I do not reside here. I invest in this. It's my priority to make it. I am happy to talk about what you want to cover. Jess has grieved at the principal, superintendent, board level. The superintendent is guiding this. You do not have to make a decision tonight but need to make a decision within 10 days. The language is in the CBA. We do have to abide in the contract. Arbitration, both sides pay their own freight. Level 1, 2, and currently level 4. The association wasn't happy with arbitration. Eric-Respond in writing within 10 days. Carlson: The previously one hired did not come to the board. There were two other applicants. It's not an easy position, lots of walking. We are looking out for when the person is single, we know who is who. It's a hard pill to swallow. We do need to sit down and negotiate. Channis-We are a small community, both are my nephews, what do I do to flip the coin? Either way, it's a hard decision. The other employee started? Eric-Yes Carlson-you do not have to deal with that part. 10 days will make the transition. We will not make a motion, we will respond.
